


### **REAL ID Act Overview**

"The federal government should set standards for the issuance of birth certificates and sources of identification, such as driver's licenses. ...

Sources of identification are the last opportunity to ensure that people are who they say they are and to check whether they are terrorists."

> --9/11 Commission Report p.390





## **REAL ID Act Overview**

- Establishes minimum standards for the secure issuance of stateissued driver's licenses and identification cards.
- Prohibits Federal agencies from accepting for official purposes driver's licenses and identification cards from non-compliant states. These purposes are:
  - Accessing Federal facilities
  - Boarding federally regulated commercial aircraft
  - Entering nuclear power plants
- **Covers 56 jurisdictions: 50 states, DC and 5 territories.**

### Authorizes DHS to:

- Issue regulations and set standards
- Determine whether a state is meeting the minimum standards based on certifications submitted by the state
- Grant states an extensions of time to meet the compliance deadline if the state provides adequate justification for noncompliance
- Make grants to states

## **REAL ID Act Overview**

#### DOES:

### Require presentation & verification of documentation showing:

- Full legal name
- > Date of birth
- > Social Security Number
- > Address of principal residence and
- > Evidence of lawful status

#### **Require Card Design to Include:**

- Biographic information, digital photo, signature, & card number
- Physical/Anti-counterfeit security features
- > Common machine-readable technology

#### Require Safeguards for the Issuance and Production of Licenses

- Copy & retain source document information
- Secure production facilities & document materials and



 Background checks & fraudulent document training for employees

#### DOES NOT:


- Does <u>not</u> create a national ID card, a Federal database of driver information, or new Federal access to state data
- Does <u>not</u> authorize DHS to regulate issuance of driver's licenses and identification cards by states
  - > State participation is voluntary.
  - Consequences for not meeting the standards
- Does <u>not</u> prevent any state from issuing noncompliant driver's licenses or identification cards
  - Noncompliant cards must incorporate a unique design and clearly indicate that the document may not be accepted for official purposes

### **TSA REAL ID Enforcement**

What happens if I show up without a REAL ID-compliant driver's license or state ID?

- Starting October 1, 2020, every traveler will need to present a REAL ID-compliant license or another acceptable form of identification to fly within the U.S.
- Passengers who are unable to verify their identity <u>will</u> <u>not be permitted</u> through the security checkpoint.
